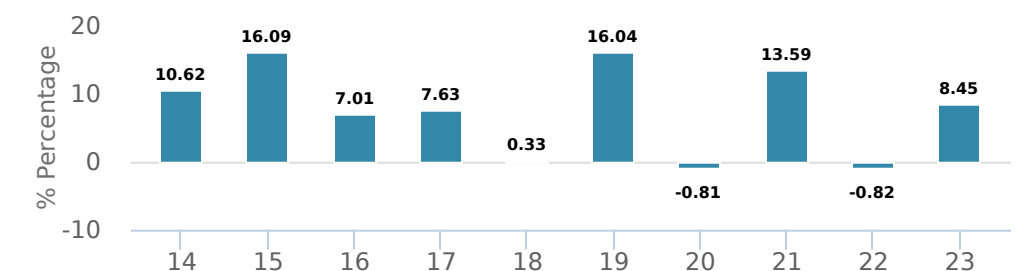

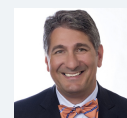
MANAGEMENT TEAM
