

CI Corporate Class Estimates for Q1 2019

Distribution estimates are based on information available as of February 28, 2019 and are subject to change.

The following table provides estimated distributions for Q1 2019 for CI Corporate Class funds. Any fund paying a distribution will do so on March 22, 2019. Investors holding shares of funds on March 21, 2019 will receive its corresponding distribution.

The estimates for Q1 2019 represent approximately 35% of the total distributions for the 2019 calendar year. The balance of the total distributions will be divided and paid equally over the next three quarters.
