INVESTMENT OBJECTIVE AND STRATEGIES

The primary investment objective of CI Bitcoin Fund (the Fund) is to provide unitholders exposure to bitcoin through an institutional quality fund platform.

To achieve its investment objective, the Fund invests all or substantially all of its assets in the CI Galaxy Bitcoin ETF (the ETF), an alternative mutual fund within the meaning of National Instrument 81-102 Investment Funds.

The ETF invests directly in bitcoin and utilizes high-quality service providers in the digital assets sector in order to manage the assets of the ETF. The ETF's portfolio is priced based on, and the net asset value of the ETF is calculated using, the Bloomberg Galaxy Bitcoin Index (BTC Index) or such other index as the Manager may select from time to time, in its discretion. The BTC Index is designed to measure the performance of a single bitcoin traded in U.S. dollars and is owned and administered by Bloomberg Index Services Limited (Bloomberg) and is co-branded with the ETF's sub-advisor, Galaxy Digital Capital Management LP. The BTC Index is calculated using Bloomberg Crypto Fixing (CFIX) as its primary input. CFIX is a pricing algorithm that uses bid and ask quotes derived from multiple pricing sources approved by Bloomberg.

As it is the ETF's intention to invest in bitcoin on a passive basis, the ETF's holdings are actively managed and accordingly, are hedged or repositioned to attempt to take defensive positions if the price of bitcoin declines or is expected to decline. The ETF may also hold cash and cash equivalents or other money market instruments in order to meet its obligations.

RISK

No changes affecting the overall level of risk associated with investing in the Fund were made during the period/year. The risks of the Fund remain as discussed in the Fund's most recently filed simplified prospectus or its amendments. The Manager reviews the risk rating for the Fund on an annual basis, at a minimum, based on the methodology mandated by the Canadian Securities Administrators to determine the risk level of the Fund. Any change to the risk rating made during the period/year was as a result of such review and was not a result of any change to the investment objective, strategies or management of the Fund.

RESULTS OF OPERATIONS

The Fund's net assets decreased by \$2.7 million to \$7.3 million from March 31, 2022 to March 31, 2023. The Fund had net sales of \$1.2 million during the year. The portfolio's performance decreased assets by \$3.9 million Series A units returned -38.5% after fees and expenses for the one-year period ended March 31, 2023. Over the same time period, the Fund's benchmark returned -37.7%. The benchmark is Bloomberg Galaxy Bitcoin Index (USD) (the Benchmark or the Index).

The performance of the Fund's other Series is substantially similar to that of Series A units, except for differences in the structure of fees and expenses. For the returns of the Fund's other Series, please refer to the "Past Performance" section.

Cryptocurrencies experienced a robust performance to the start of the year. Equities were resilient, with large-capitalization information technology sector stocks leading markets higher, their correlation to cryptocurrencies remaining strong. In March SVB Financial Group and Signature Bank failed, as a result investor confidence in the U.S. banking system decline. Bitcoin was viewed as an attractive alternative and as a result was up +22.47% in March. Bitcoin outperformed the broader cryptocurrency market, and Ethereum also saw its best quarter since 2021.

As a single-asset fund, the Fund's performance was driven solely by the performance of Bitcoin held by the Underlying Fund.

We increased the Underlying Fund's position in Bitcoin in line with share creations and trimmed the Underlying Fund's position in Bitcoin in line with share redemptions.

RECENT DEVELOPMENTS

The Fund's mandate is to track the performance of Bitcoin. As such, the Underlying Fund's portfolio is weighted 100% to Bitcoin.

Independent Review Committee

Effective October 6, 2022, John Sheedy became a member of the Independent Review Committee (IRC) of CI Funds.

RELATED PARTY TRANSACTIONS

Manager, Portfolio Adviser, Trustee and Registrar

CI Investments Inc. is the Manager, Portfolio Adviser, Trustee and Registrar of the Fund. CI Investments Inc. is a subsidiary of CI Financial Corp. The Manager, in consideration for management fees, provides management services required in the day-to-day operations of the Fund. The Manager bears all of the operating expenses of the Fund (other than taxes, borrowing costs and new governmental fees) in return for an administration fee.

The Manager received \$0.03 million in management fees and a nominal amount in administration fees for the year.

Management Fees

Approximately 31% of total management fees were used to pay for sales and trailing commissions. The remaining 69% of management fees were used to pay for investment management and other general administration.

Related Fund Trading

Related fund trading occurs when a Fund purchases or sells units/shares of another Fund managed by the Manager. During the period/year ended March 31, 2023, the Fund engaged in related fund trading or held position(s) in related fund(s) at the end of the period/year.

Independent Review Committee

The Manager, in respect of the Fund, received the following standing instructions from the IRC with respect to related party transactions:

The applicable standing instructions require, amongst others, that related party transactions be conducted in accordance with the Manager's policies and procedures and applicable law and that the Manager reports related party transactions periodically to the IRC and advise the IRC of any material breach of such policies. The Manager's policies and procedures require that investment decisions in respect of related party transactions (a) are free from any influence by an entity related to the Manager and without taking into account any consideration relevant to an entity related to the Manager; (b) represent the business judgment of the Manager, uninfluenced by considerations other than the best interests of the Fund; (c) do not exceed the limitations of the applicable legislation; and (d) achieve a fair and reasonable result for the Fund.

Except as otherwise noted above under Related Party Transactions section, the Fund was not a party to any related party transactions during the period/year ended March 31, 2023. If the Fund invested in related party transactions, it relied on the IRC's standing instructions regarding related party transactions during this reporting period/year.

The Effective HST tax rate is calculated using the attribution percentage for each province based on unitholder residency and can be different from 13%.

(3) The trading expense ratio represents total commissions and other portfolio transaction costs expressed as an annualized percentage of daily average net assets during the period/year, including the Fund's proportionate share of such expenses of any underlying fund(s), if applicable.

(4) The Fund's portfolio turnover rate indicates how actively the Fund's portfolio advisor manages its portfolio investments. A portfolio turnover rate of 100% is equivalent to the Fund buying and selling all of the securities in its portfolio once in the course of the fiscal period/year. The higher a Fund's portfolio turnover rate in a period/year, the greater the trading costs payable by the Fund in the period/year, and the greater the chance of an investor receiving taxable capital gains in the period/year. There is not necessarily a relationship between a higher turnover rate and the performance of a Fund. Portfolio turnover rate is calculated by dividing the lesser of the cost of purchases and the proceeds of sales of portfolio securities for the period/year, and excluding cash and short-term investments maturing in less than one year, and before assets acquired from a merger, if applicable, by the average of the monthly fair value of investments during the period/year.



Annual Compound Returns

The following table shows the Fund's annual compound returns for each year indicated, compared to the Bloomberg Galaxy Bitcoin Index (USD).

The Bloomberg Galaxy Crypto Index (BGCI) and the Bloomberg Galaxy Bitcoin Index (BTC) were launched by Bloomberg Index Services Limited and Galaxy Digital Capital Management. BGCI is a capped market capitalization-weighted index designed to measure the performance of the largest digital assets traded in USD. Eligible index constituents are diversified across different categories, including stores of value, mediums of exchange, smart contract protocols and privacy assets. BTC is designed to measure the performance of a single bitcoin traded in USD.
