**What does the fund invest in?**

Sentry Money Market Class aims to maximize short-term income and preserve capital by investing substantially all of its assets in securities of Sentry Money Market Fund. The underlying fund invests in high-quality short-term debt instruments.

**How risky is it?**

The value of the fund can go down as well as up. You could lose money.

One way to gauge risk is to look at how much a fund's returns change over time. This is called "volatility".

In general, funds with higher volatility will have returns that change more over time. They typically have a greater chance of losing money and may have a greater chance of higher returns. Funds with lower volatility tend to have returns that change less over time. They typically have lower returns and may have a lower chance of losing money.

**Risk Rating**

CI Investments Inc. has rated the volatility of this fund as **low**.

This rating is based on how much the fund's returns have changed from year to year. It doesn't tell you how volatile the fund will be in the future. The rating can change over time. A fund with a low risk rating can still lose money.

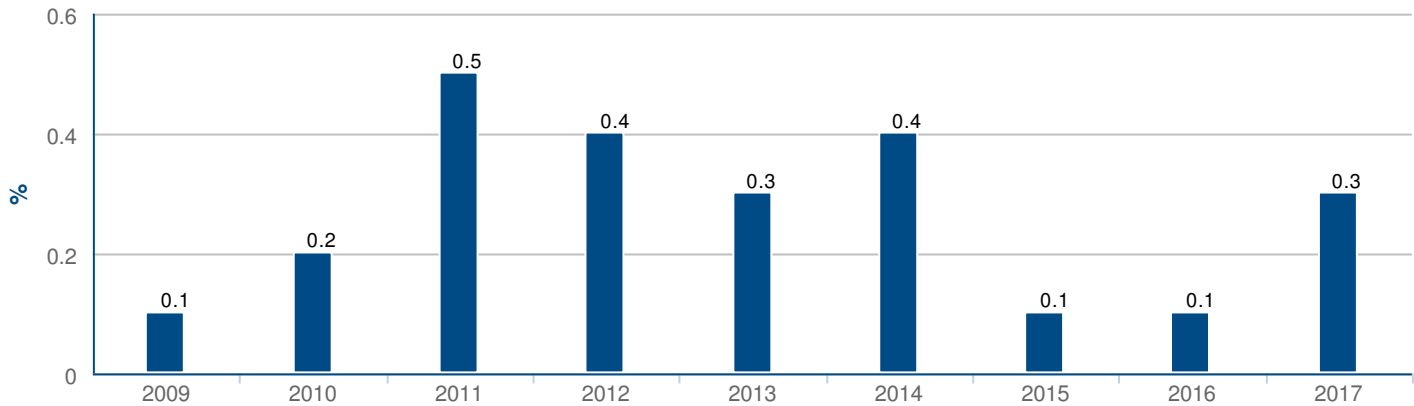

## How has the fund performed?

This section tells you how Series F securities of the fund have performed over the past 10 years. Returns are after expenses have been deducted. These expenses reduce the fund's returns.

### Year-by-year returns

This chart shows how Series F securities of the fund performed in each of the past 10 years. The fund did not drop in value in any of the 10 years. The range of returns and change from year to year can help you assess how risky the fund has been in the past. It does not tell you how the fund will perform in the future.



### Best and worst 3-month returns

This table shows the best and worst returns for Series F securities of the fund in a 3-month period over the past 10 years. The best and worst 3-month returns could be higher or lower in the future. Consider how much of a loss you could afford to take in a short period of time.

<b>Best return</b>	0.2%	July 31, 2011	Your investment would rise to \$1,002

### Average return

A person who invested \$1,000 in Series F securities of the fund 10 years ago would have had \$1,044 as of April 30, 2018. This works out to an annual compound return of 0.4%.

### Who is this fund for?

Investors who:

- are willing to accept a low degree of risk
- are seeking to preserve their capital.



This series is generally only available to you if you have a fee-based account with your representative's firm.

### A word about tax

In general, you'll have to pay income tax on any money you make on a fund. How much you pay depends on the tax laws where you live and whether or not you hold the fund in a registered plan such as a Registered Retirement Savings Plan, or a Tax-Free Savings Account. Keep in mind that if you hold your fund in a non-registered account, fund distributions are included in your taxable income, whether you get them in cash or have them reinvested.

## How much does it cost?

The following tables show the fees and expenses you could pay to buy, own and sell Series F securities of the fund. The fees and expenses - including any commissions - can vary among series of a fund and among funds. Higher commissions can influence representatives to recommend one investment over another. Ask about other funds and investments that may be suitable for you at a lower cost.

### 1. Sales charges

No sales charge is paid when you own Series F securities of the fund.

## 2. Fund expenses

You don't pay these expenses directly. They affect you because they reduce the series' returns.

As of March 31, 2018, the expenses of Series F of the fund were 0.50% of its value. This equals \$5.00 for every \$1,000 invested.

	Annual rate (as a % of the fund's value)
<b>Management expense ratio (MER)</b> This is the total of the series' management fee and operating expenses. CI Investments Inc. waived or absorbed some of the series' expenses. If it had not done so, the MER would have been higher.	0.50%
<b>Trading expense ratio (TER)</b> These are the fund's trading costs.	0.00%

**Effective on or before December 31, 2018, CI Investments Inc. will be responsible for all operating expenses (other than certain fund costs).**

### More about the trailing commission

No trailing commission is paid to your representative's firm when you own Series F securities of the fund.

## 3. Other fees

You may have to pay other fees when you buy, hold, sell or switch securities of the fund.

Fee	What you pay
<b>Short-term trading fee</b>	There is no short-term trading fee for this fund.
<b>Switch fee</b>	There is no switch fee for this fund.
<b>NSF cheque fee</b>	We will charge you \$30 if a payment for a purchase of securities is returned by your bank for any reason.
<b>Fee-based account fee</b>	Generally, you must participate in an eligible fee-based or wrap program with your representative's firm to purchase this series. Your representative's firm may charge you a service fee, which is negotiated between you and your representative's firm and paid directly to them. In certain cases, we may have an arrangement with your representative's firm to collect the service fee on behalf of your representative's firm. In those cases, the service fee must not exceed 1.50% of the average value of the net assets that you hold in the fund during each complete calendar month.

## What if I change my mind?

Under the securities law in some provinces and territories, you have the right to:

- withdraw from an agreement to buy mutual fund securities within two business days after you receive a simplified prospectus or Fund Facts document, or
- cancel your purchase within 48 hours after you receive confirmation of the purchase.

In some provinces and territories, you will also have the right to cancel a purchase, or in some jurisdictions, claim damages, if the simplified prospectus, annual information form, Fund Facts document or financial statements contain a misrepresentation. You must act within the time limit set by the securities law in your province or territory.
