What does the Fund invest in?

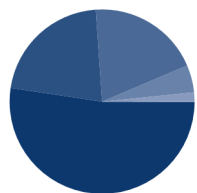
The Fund invests in the Signature Dividend Corporate Class. The underlying fund invests mostly in Canadian shares.

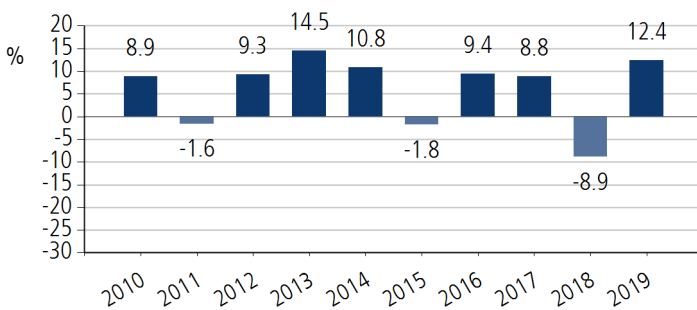
How has the Fund performed?

Average return

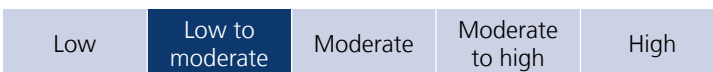

This works out to an average of 5.95% each year. The returns are after the MER has been deducted. The MER of the Segregated Fund includes insurance fees. The insurance fees and other costs will reduce the returns of the Fund. Past returns do not tell you how the Fund will do in the future. Your return will vary based on your guarantee option and personal tax situation.
