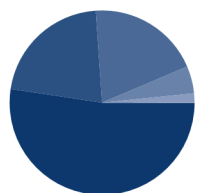
The fund invests in the Signature Dividend Corporate Class. The underlying fund invests mostly in Canadian shares.

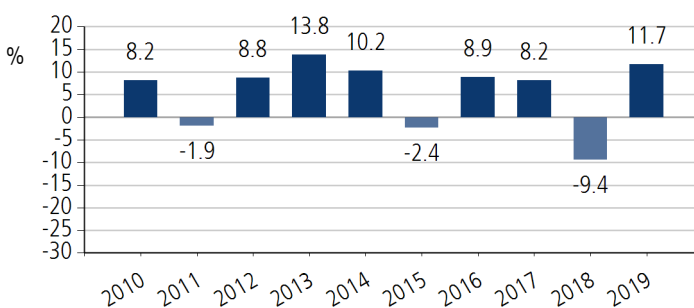
### How has the fund performed?

#### Average return

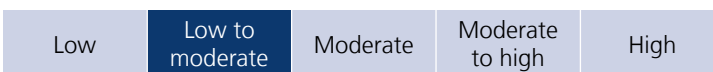
