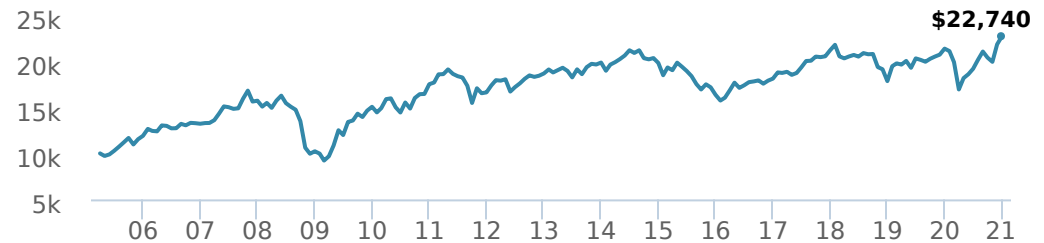

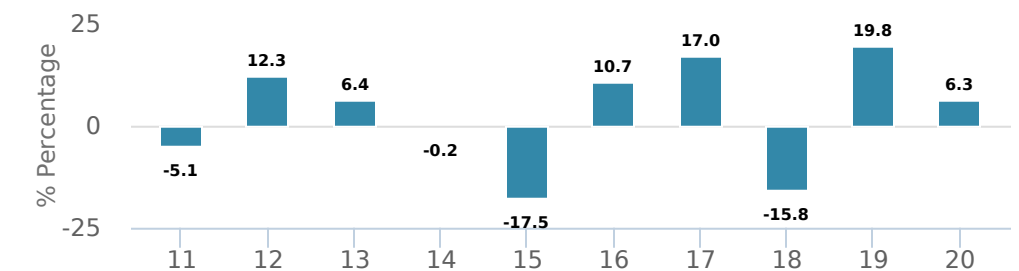

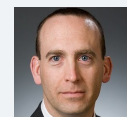
MANAGEMENT TEAM

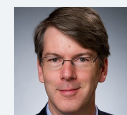
