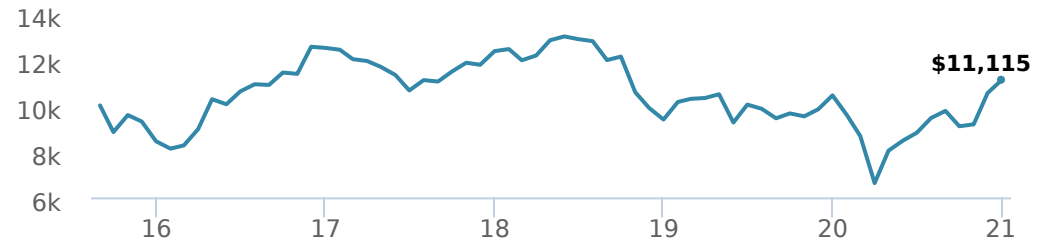

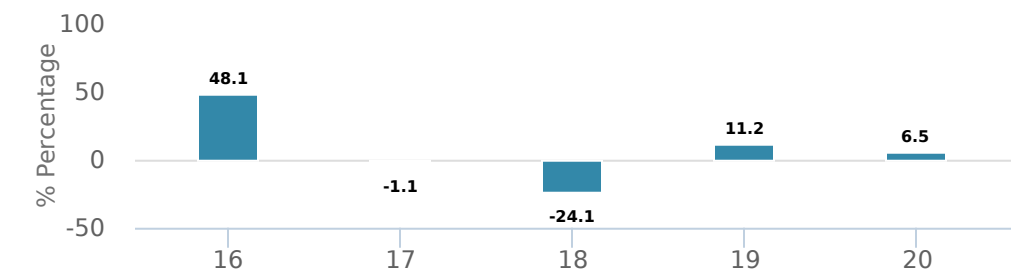

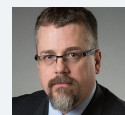
MANAGEMENT TEAM
