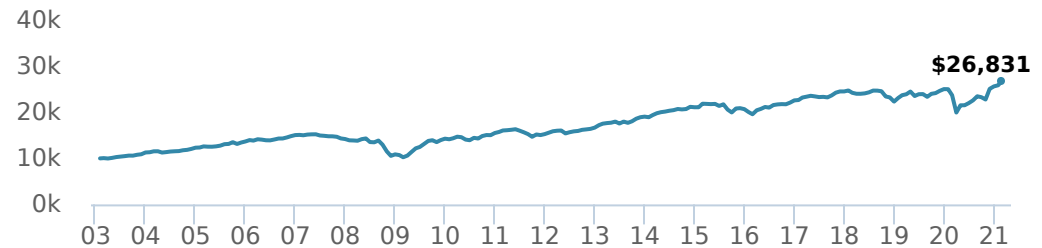

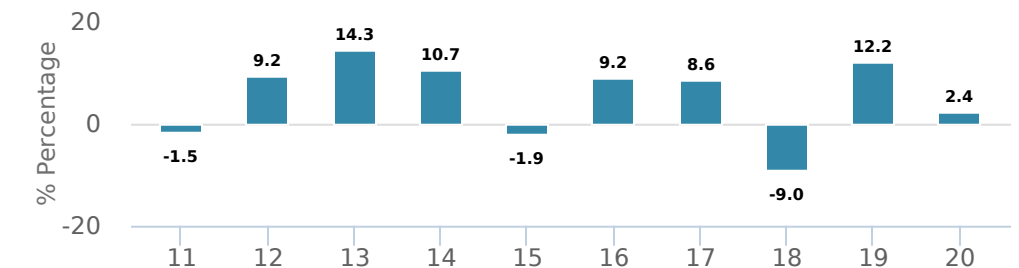

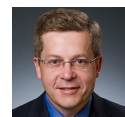
MANAGEMENT TEAM
